Assessment system of learning outcomes

Current control is carried out during the semester during lectures, practical classes and is estimated by the amount of points scored (maximum amount - 60 points; minimum amount - 25 points). The result of the semester exam is evaluated in points (maximum number - 40 points, minimum number of credits - 25 points).

The applicant should be considered certified if the sum of points obtained from the final performance test is equal to or greater than 60. The final grade is calculated taking into account the points obtained during the exam and the points obtained during the current control of the accumulative system.
