Discipline policies

Academic integrity is a must when studying the subject «Public Governance». Simon Kuznets KhNUE policy, standards and procedures for academic integrity, as well as responsibility for the admission of manifestations of academic dishonesty are regulated by the Code of Academic Integrity of Simon Kuznets KhNUE (link: https://www.hneu.edu.ua/kodeks-akadem-dobrochesnosti).

Policy on skipping classes: skipping classes without a reason is not allowed, missed classes are completed by the student individually during consultations or remotely through the site of personal learning systems.

The procedure for re-conducting control measures is regulated by the following documents:

- 1) Temporary provision "On the procedure for assessing the learning outcomes of students on the cumulative scoring and rating system";
 - 2) «The order of liquidation of academic debts of students of KhNEU. S. Kuznets».

According to these documents, the transfer of an unsatisfactory grade is allowed according to the transfer schedule, but not more than twice. If there are good reasons, the transfer can be done on an individual schedule.
